HUKAMNAMA

So called professor Darshan Singh raagi, on account of inappropriate criticism of Dasmesh Pita Sri Guru Gobind Singh Ji during his Kirtan at the Gurdwara Sahib Rochester, New York (USA), was summoned to be present and explain in person at the Akal Takhat Sahib on 22 Mghar, Nanakshahi 541 (5 December, 2009), 25 Poh, Nanakshahi 541 (7 January, 2010) and 17 Maagh, Nanakshahi 541 (29 January, 2010). However Darshan Singh, due to personal ego and selfishness and pride he failed to appear before the five Singh Sahibban in Akal Takhat sahib and became culpable before Guru Granth and Guru Panth

Sangat (members of Sikh congregation) are reminded that on 26 Poh, Nanakshahi 539 (8 January, 2007) they were advised by a Hukamnama to be careful/aware due to misleading preaching by Ragi Darshan Singh Ragi and he was advised not to indulge in malicious, false and misleading activities. In addition, on 23 Jeth, Nanakshahi 540 (6 June 2008) he was affectionately advised against causing confusion in the Panth. But instead of complying to the advise and orders from the Akal Takhat, Darshan Singh Ragi ignored the directives and continued his activities to cause confusion and divisions in the Panth. So much so that he used a very awful and objectionable language and even compared the Singh Sahibaan to Massa Rangharr in his presentations.

After lengthy deliberation on all these situations, the five Singh Sahibaan have accused Darshan Singh Ragi of being slanderer of the Gurus and a rebel/recalcitrant to Sikh Panth. Because of being deprived of the honor of being in the Sikh Panth and being an outsider he is stripped of the rights and privileges of being a Sikh. All those Gursikhs who accept and honor Guru Granth Sahib as Guru, Dasmesh Pita Guru Gobind Singh as Guru-Pita (father) and followers of Guru Nanak, are directed from the Akal Takhat Sahib that they must not mingle with Darshan Singh Ragi.

All the sangats (congregations, Gurdwaras), here and around the world are enjoined that they must not allow Darshan Singh Ragi and any of his supporters to speak from the stage nor facilitate such effort. Anyone who violates this advisory will be considered guilty and apostate from Sikhi.
